
2018 Changes: Start Getting Ready Now!

Is LCIS of the Breast reportable in 2018?

This was a topic of hot discussion on the NCRA Facebook page. Many are convinced that because AJCC stated they were dropping LCIS from the list of applicable histology codes that it is no longer reportable.

Answer: AJCC does not determine what cases are required to be reported. The CoC and the Central Cancer Registry (under the guidelines provided by CDC NPCR) determine what cases are to be reported. Until we get official notification stating otherwise from the CoC and CDC NPCR, LCIS of the breast IS STILL REPORTABLE in 2018!!

DO NOT SUBMIT CASES DIAGNOSED IN 2018 UNTIL YOU HAVE CONVERTED TO NAACCR VERSION 18!



Focus on finishing all 2017 cases. Go ahead and review the 2018 casefinding reports to identify 2017 cases not seen until 2018.

If you do not want to wait to *start* abstracts for 2018 cases, it is important that you include detailed stage and SSDI information in your text so that you can go back into these cases to make the 2018 changes without having to re-review the medical record.

Be sure to exclude these 2018 cases from your transmissions until you receive the upgrade from your vendor containing the 2018 changes AND the NC CCR 2018 edit metafile. Any NAACCR version 16 files containing 2018 cases will be rejected.

You may want to run a few reports on your stage data before creating the submission file to ensure the SSDI's, SS2018 and AJCC TNM was assigned appropriately on all cases.

Please review your 2018 staging data carefully before transmitting to the CCR.

North Carolina Central Cancer Registry: Re-Coding Audits Dianna Stucky, BS, CTR NC CCR QC Supervisor/Audit Coordinator

The CCR is partially funded by the National Program for Cancer Registries (NPCR) and is governed by its program standards. Comprehensive quality control audits of the CCR's data is conducted in accordance with these standards. In addition, consistent errors observed while manually reviewing linkage and consolidation cases help identify which audits may be necessary to properly evaluate possible data errors in a larger dataset. Over 39 audits of varying aspects were conducted in 2017 by the Quality Management staff. Here are two brief summaries of such audits that identified a large number of errors in the data:

AJCC TNM Staging for Bladder

This audit was based on the AJCC TNM 7th edition rule for Bladder Primaries that states: TURBT's (transurethral resection of bladder tumor) are part of clinical staging <u>only</u>.

Purpose: To review the AJCC TNM staging fields for Bladder primaries with TURBT's only

Criteria: Primary site of Bladder (C67.9) with a surgery code between 20-27

Study Period: Year of diagnosis 2016

Results:

- 1,800 cases with the above criteria were reported and manually reviewed.
- 230 cases (18%) had incorrect stage in the pathologic TNM data items. Common errors were:
 - o a partial or radical cystectomy was not done and the findings from the TURBT was used to assign the pT.
 - o the pathologic TNM fields were assigned to 'X'.
- The pathologic TNM data items for these 230 cases were corrected to "blanks".

Key Abstracting Points:

It is understandable that a TURBT could be mistaken as a procedure that qualifies for pathologic staging because TURBT's are listed with a surgery code in the Surgery of Primary Site data item. But, when it comes to staging, there are different rules and exceptions, and they differ based on the primary site!

- For bladder, a partial or radical cystectomy must be done to assign the pathologic T (pT).
- A TURBT does NOT qualify for assigning the pT. The findings from the TURBT are used to assign the clinical T (cT).
- When to leave pT blank: If a partial or radical cystectomy is NOT DONE, the pT is to be left blank.
- When pT should be pX: If a partial or radical cystectomy WAS DONE, but the extent of involvement is unknown to the physician, assign pX.


Renal Cell Carcinoma for Kidney

This audit was based on Rule H5 in the Multiple Primary and Histology Coding Rules Manual (Kidney Schema) that states: If there is renal cell carcinoma, NOS 8312/3 and <u>one</u> specific renal cell type (listed in Table 1), code the specific type.

Purpose: To determine if Renal Cell Carcinoma could be recoded to a more specific subtype **Criteria**: Primary site of Kidney (C64.9) with a histology of Renal Cell Carcinoma, NOS (8312/3) **Study Period**: Year of diagnosis 2015-2017

Results:

- 1,509 cases with the above criteria were reported and manually reviewed.
- 481 cases were recoded to a more specific subtype based on text documentation...that's 33%! See the importance of text!
- The pie chart shows the recoded subtype ratio. 89% of the 481 cases were recoded to Clear Cell carcinoma (8310/3).



Key Abstracting Points:

It is important to follow the MP/H rules AND follow them in order!

Renal Cell Carcinoma is considered a non-specific term. Even though Renal Cell Carcinoma (8312/3) has a higher ICD-O-3 histology code than Clear Cell Carcinoma (8310/3), MP/H Rule H5 clearly states that the histologies listed in Table 1 have priority over Renal Cell Carcinoma, NOS.
